Killgerm Group supplies products and services within the whole of Europe, the Middle East, the Far East, Australasia, Africa, North America and South/Central America. Apart from the products which Killgerm Group manufactures or formulates itself, it is a major pest control distributor.

The Group includes:

1. Killgerm Division, with operations based in the UK, Belgium, Netherlands, Germany, Poland, Portugal, Spain and Switzerland.
2. PestWest Division, with operations based in the UK, USA, Australia and China.
3. Travelwise Division, with operations solely in the UK.

The Killgerm Group employs 200 people worldwide.

Our supply chains are extensive with hundreds of suppliers worldwide.

OUR POLICIES ON SLAVERY AND HUMAN TRAFFICKING

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. - Identify and assess potential risk areas in our supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.

- Protect whistle blowers.

SUPPLIER ADHERENCE TO OUR VALUES

We have written to our suppliers requesting confirmation from their senior management that they are satisfied that their operations (both in the UK and overseas) have suitable preventative measures in place to prevent modern slavery. We are committed to having an ongoing and open dialogue with our suppliers and working with them to ensure robust preventative measures are in place and will continue to seek confirmations over time.

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide training to our staff.
