Respiratory protection

Remove the container cap.

Place each smoke generator on a fireproof base approximately 300 mm x 300 mm

When a number of generators are being used, space them throughout the area to be tested and prepare all for ignition before lighting the first.

Light the ignitor using a match.

Do not leave lighted match on generator. AVOID naked flames and hot surfaces
